Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2024-25 educational progress for Crescent Academy Middle/High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about accountability, student assessment, and teacher quality. For the 2025-26 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student group in 2024-25. An Additional Targeted Support (ATS) school is one that had at least one student group performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state, had a graduation rate at or below 67%, failed to exit CSI status in 2024-25, or failed to exit ATS status in 2021-22. Some schools are not identified with any of these labels. In these cases, no status label is given.

Our school has not been given one of these labels.

While the students at Crescent Academy are continuously showing growth in core content areas, they are still performing below, on average, state and national level norms. To address this learning gap, Crescent Academy will continue to place a strong focus on supplemental instructional programs and targeted interventions for all students.

State law requires that we also report additional information.

**1. PROCESS FOR ASSIGNING PUPILS TO THE SCHOOL**

Crescent Academy is a public charter school and enrollment is open to all students, regardless of where they reside within the state of Michigan. Each spring we hold a re-enrollment period for existing students. After re-enrollment an open enrollment period is posted for any new families that are interested in attending Crescent Academy. New students and their families meet with the Enrollment Officer to learn all about Crescent Academy and its programs before enrolling. If more students enroll than we have spots, a lottery is held and students that do not obtain an open space are placed on a waiting list and enrolled as spots become available.

**2. THE STATUS OF THE 3-5 YEAR SCHOOL IMPROVEMENT PLAN**

The MICIP plan was submitted, and approved, at the close of the 2021-2022 school year. The academy continues to make progress towards its school improvement goals and each year strategies and activities are evaluated for effectiveness and revised as necessary to continue moving our school forward in student achievement for all students. At this time, Crescent Academy Middle School Building does not offer any specialized schools.

Crescent Academy's curriculum follows state and Common Core standards in conceiving its curriculum, a copy of which can be provided upon request in the main office. In Reading, Crescent Academy has implemented Oakland Schools ELA Common Core Aligned Units. In Mathematics, Crescent Academy recently implemented the Great Minds Eureka Math Program. Additionally in reading and math, Crescent Academy utilizes iXL to provide whole and small group instruction along with individualized support for students.

**5. THE AGGREGATE STUDENT ACHIEVEMENT RESULTS FOR ANY LOCAL COMPETENCY TESTS OR NATIONALLY NORMED ACHIEVEMENT TESTS**

Students at Crescent Academy take the NWEA assessment to track proficiency and growth over the course of the school year, the table below summarizes their average percentile, as a grade.
